Who is an administrator?

Any natural or legal person who, in the exercise of their right to petition, information and / or right or access to administrative justice, is directed to the Public administration.

What is a procedure?

It is all management that the administered makes before the administration, by virtue of a norm that establishes it to obtain a right, eliminate a restriction, consolidate a legal situation or obtain a permit or grant.

... It is constituted by the set of actions or proceedings related to each other, understood or processed according to the order and manner prescribed, either by the legislator or by the Administration and that are necessary to specify or achieve an effect final legal.

We gave the defendant the court file number that was being

processing at that time, which is part of a series of actions or interrelated procedures and these responses are still required to end this saga and provide us with our right to participate and receive adequate and truthful information to finalize our previous Amparo in our interest.

The defendants never asked for more time or additional clarification of the documents.

We presume that the defendants knew exactly what we asked for, why and what important that it is for our interests. We presume they knew this is part of an ongoing process that began with petitions and protests in December 2020 and that has come and gone to court. It's a long list of questions, but reasonable and not frivolous for us. For us these questions are the only way to get to the truth on many levels of a huge problem with many facets and we believe that we are being harmed by many falsehoods and willful omissions of the defendants.

How are extensions applied, once the only prevention for written to the administrator?

According to article 29 of Executive Decree 37045 in its third paragraph it indicates: "In exceptional cases and when the regulatory provisions so establish, the entity or body of the Public Administration has the power to require additional extensions or clarifications of the documents already provided in the request by the citizen. Said requirement shall be made in writing, in a manner motivated and for one time only. "

We must remember that one of the fundamental principles of the procedure administrative is the real truth. Therefore, the principles of improvement Regulatory should not be construed in opposition to this principle. In this sense, The public Administration must differentiate the sole prevention, established in the Article 6 of Law 8220, which imposes on the administration the obligation to review the request and, to the administrator, to complete it in accordance with the provisions of the law, the regulation or decree.

While what is stipulated in the paragraph here transcribed of article 29 of the Decree

Executive 37045, establishes that, exceptionally and, to strengthen the principle of the real truth of the administrative procedure, the Administration through technical and legally justified administrative resolution may request the extension or clarification of a previously requested requirement. In this sense, Administration may suspend the administrative procedure or even request an extension of the term in the same resolution that requests the extension or clarification of the requirement, the foregoing must also be justified technically and legally. In the case of legal justification, the rule can be invoked that establishes the procedure of said procedure that contemplates the extension exceptional or, article 258 of the General Law of Public Administration.

Because they never requested a clarification or extension since it is about consolidate an ongoing legal process that involved our previous Amparo de answer that was never duly answered we consider that they are violated our rights and we are entitled to the jurisdictional protection of this court by right of reply.

Question: Show "the science" that we deny WITH EACH OF THE PIECES OF VALID SCIENCE ON WHICH IT IS SUPPORTED that will demonstrate that their actions do not violate the General Law of the Administration Public Article 16. 1. In no case may acts contrary to the rules be dictated. unequivocal rules of science or technology, nor to elementary or technical rules, nor to elementary principles of justice, logic or convenience. Any claim that you do not dispute will be considered true and will show that you are violating the article 16.1. You must refute everything you say with something reasonably valid and not with pseudoscience.
