We demand the following non-technical reports in 3 business days (Article 262).

1. <u>Provide all semi annual reports referred to in the following law:</u> The Commission must submit a semi-annual report to the authorities of the Ministry and the Fund. - Regulations to the National Vaccination Law No. 32722

2. Provide verified evidence of your (Costa Rica's) notification to inform the other States Parties, through the Secretary General of the Organization of American States, of the provisions the application of which Dr. Salas has suspended, the reasons that gave rise to the suspension, and the date set for the termination of such suspension. See international law: http://www.hrcr.org/docs/American Convention/oashr6.html Any State Party availing itself of the right of suspension shall immediately inform the other States Parties, through the Secretary General of the Organization of American States, of the provisions the application of which it has suspended, the reasons that gave rise to the suspension, and the date set for the termination of such suspension, and the date set for the termination of such suspension.

We demand the official notification where Dr. Salas and Costa Rica informed the other States Parties to the present Covenant, through the intermediary of the Secretary-General of the United Nations, of the provisions from which it has derogated and of the reasons by which it was actuated. see: Syracusa Principles Article 4 (3.) :Version en Ingles:

- A. We provided the following NON technical questions to the Minesterio de Salud and Daniel Salas on August 23, 2021by ways of electronic mail and the respondent has failed to respond. These questions are extremely important to our interests and in resolving an ongoing legal matter that began December 7, 2020 with our claim of protest.
- B. Salas answered another petition sent the same day as these questions were sent, so it is very suspicious he does not want to answer these EXTREMELY important questions. We're asking these questions to see if he violated international law in which Costa Rica is a member state. We believe he is hiding something which is why he did not respond to this particular email but responded to the other email petition sent the same day. These are serious to our interests as well as the public interest. These questions are absolutely NOT voluminous and only a mere 4 questions. In good faith we gave extra time. However, we consider our rights to be violated.
- C. It is extremely concerning to us about question #4. We need to know if this is a threat to our livelihood, lives and our private decision making. We want to know what is in that protocol. Are they plotting against us because we disagree and want to expose, to what is in our opinion to be a "fraud"? It is really important to know what is in those emails unredacted and who is involved with these urgent meetings regarding "X CORRESPONDING PROCEDURE Attached sheet" and all notes and emails regarding the "URGENT Discussion at meeting". We feel threatened against our own well-being for standing up for what we believe. We would have liked to participate in a meeting involving us and also the design of the protocol on how to deal with people who protest the restrictions considering this is a participatory government under Article 9 of the Costa Rica Constitution. Secret protocols are unacceptable in a participatory government in our opinion. Why keep it a secret as an attachment that is internal but not publicly known? We believe in our opinion Daniel Salas is hiding a serious internal protocol in which he does not want have in the public view due to public scrutiny, which is why he is refusing to answer. We require this writ of protection be granted due to the seriousness of this matter.
